. Councilmember Assignments:

Councilmembers discussed duty assignments and changes. The results follow:

Olita Johnston: City of Hauser Historian

Cindy Espe will handle Hauser Rinse Station/Memorandum of Understanding

. Reporting Structure:

- Mayor Johnston said the Secretary of Planning and Zoning should have minutes for each of their meetings. She suggested Councilmembers read the Association of Idaho Cities rules on Planning and Zoning. (The City Clerk copied the AIC Section on Planning and Zoning, "Citizen Planners: The Establishment, Form and Duties of the Planning and Zoning Commission" for Councilmembers on May15, 2012.)
- Mallon made reference to Idaho Code Title 50 and 63. He said Council did not Supervise Planning and Zoning, and said "The boss is supposed to know."

. Long Range Plans:

Mallon said the City has acreage and asked, "What are we going to do with the property we have?" He referenced City Trails including Hauser Heights and Waterford Estates, asking about bike paths and there is nothing written about Hauser Heights. Discussion followed. He also asked what happened to "Develop a Gateway Entrance." Discussion followed. Councilmember Lefebvre said he would work with Mallon to develop Budgeting Strategies for these kinds of projects. Mayor Johnston addressed Mallon saying she didn't think anything could be done at this point until the budgeting meetings are scheduled in the next three or four months. We need to know how much money is available for such Projects. Councilmember Hatfield also commented that at the budget meetings last year, they didn't know how much we'd have to spend on the Comprehensive Plan and Develop Code revisions. Mayor Johnston said, "The City has to stop borrowing from our savings."

. Business Charge/Credit Accounts:

Mayor Johnston said one account is being "worked on right now."

. Initiate Budget Schedule:

Mayor Johnston asked to have the first Budget Meeting before the end of May. Discussion followed. Lefebvre said Wednesdays are usually the best days for him since he has that day off but his schedule changes from week to week but generally knows his schedule by Friday for the following week. Evenings are usually okay. Mayor Johnston asked Lefebvre to let Councilmembers know so a meeting can be scheduled.
