Peone responded that this would be between the Post Falls Highway District and Kootenai County since that property on that side of the road is not in Hauser city limits. Discussion followed.

Regarding grass and weeds on the City property: Boy Scouts have to perform civic duty in order to get one of their badges. Curry stated he has used them. McCoy responded that there are liability issues, and someone would have to supervise them.

Entry sign for the City of Hauser: Some time ago an entry sign for the City was discussed. This would be a tool to convey to the city at large what was going on in the City.
