## . Claire Hatfield, City of Hauser Properties – RC&D

Councilmember Hatfield said the attorney is asking for direction on whether to send a letter regarding the removal of the fence at Waterford, and asked for a vote of councilmembers to have the attorney write the letter telling them to remove the fence. Councilmember Lefebvre added that the letter would give the association 30 days to remove the fence or the City would remove the fence and bill the HOA.
